1. Customer Information Collected by the Company

(1) The Company may obtain information you provide us in connection with your use of the Service. This can include the following information:

- Player name

Note: The player name should not contain your real name, initials, or any other information that could identify you.

- E-mail address
- In-game ID, password, etc., determined at your option Contact Information

(2) The Company may obtain customer information in connection with your use of the Service. This can include the following information:

- Communication information (IP address, etc.)
- Information about your terminal and OS (terminal identifier, advertisement identifier, terminal information, OS information, setting information on the terminal, etc.)
- Information about the area in which you live
- In-app purchase information • In-app play data and error data

(3) The Company may use cookies and similar technologies in connection with your use of the Service. Cookies are small pieces of data sent to your browser or terminal. You may disable or restrict cookies by changing the settings on your browser or terminal. However, if you do so, your use of the Service may be restricted.

2. Purpose of Use of Customer Information

(1) Use for the purpose of providing the Service:

The Company uses Customer information it obtains to provide, maintain and improve the Service and to respond to inquiries.

(2) Use for any purpose other than providing the Service: The Company uses Customer information it obtains for the Company's market analysis, development, provision, maintenance and improvement of products, services and campaigns, etc., other than the Service, and to respond to inquiries.

(3) Advertising and marketing:

The Company uses Customer information it obtains to provide Customers with information about the Company's or a third person's products, etc. (including sending push notifications and displaying advertisements).

(4) Preparation and provision of statistical information: The Company may disclose or provide information obtained from Customers to a third person after processing it into a statistical form that does not identify the Customer personally.

3. Cases Where Customer Information is Disclosed to Third Persons

(1) Other users of the Service may be able to view some of your information (player name, game play data, etc.).

(2) In connection with the provision of the Service or to the extent not restricted by applicable law

and regulations, the Company may provide Customer information to outsourcing contractors, information collection module providers, advisors, platformers providing social networking services, ad networks and/or other third persons for the purpose of providing information on our current or future products, etc. These third persons include third persons located outside of your country/region.

(3) The Company may provide information obtained from Customers to a third person after processing it into a statistical form that does not identify the Customer personally.

(4) The Company may disclose Customer information to third persons without your consent if so required under applicable laws and regulations.

(5) In the event of a corporate merger, sale of assets, acquisition, dissolution, restructuring, bankruptcy, change of control or any other similar event, Customer information may be transferred to our successors as a result of the foregoing.

Also, in examining the foregoing, your information may be provided to third persons to the extent necessary for such examination.

4. Information Collection Module

The Company may use a third-person information collection module that is independent of the functions of the Service to investigate trends in the use of the Service, to operate the Service effectively, to prevent fraud or for any other relevant purposes. Please refer to the privacy policy established by the third person for the management of the information collected by the information collection module.

5. Storage and Transfer of Customer Information
